The Board of County Commissioners met in regular session at 10 o'clock A.M. with Chairman John L. Allen, and Commissioner Vigo N. Miller, present. Commissioner F. D. Ball, absent.

The minutes of the previous meeting were read and approved.

The application for widow's pension by Mrs. Ned Davidson was presented and granted and warrant ordered drawn for the same.

Mr. W. A. James, attorney at law, presented an appointment as assistant County and Prosecuting Attorney from George Vorhees, county and prosecuting attorney elect, and it appeared that Mr. Voorhees, had not qualified as provided by law and a motion was regularly made and carried that Mr. James be employed by the Board as legal advisor to the county officers until the arrival and qualification of Mr. Voorhees.

The following road districts were established and road supervisors appointed.

District 1-South boundary county to Cottonwood Creek. S. W. Baldwin.

District 2-From Cottonwood Creek including Fall River, Cora from south line J. M. Noble ranch, north including upper Green River. S. R. Hill.

District 3-From south line Noble ranch, including balance of county lying on east side of Green River. E. D. Sandlin.

Pursuant to Chapter 177, Section 2864 the Commissioners hereby levy a School Poll Tax of \$2.00 upon each person between the ages of 21 and 50 years, also \$2.00 Road Poll Tax for each able bodied male person between the ages of 21 and 50 years.

Pursuant to Chapter 98, Section 1366 of the compiled statutes of the State of Wyoming, 1920, and after having computed the estimated expenses of maintaining the several departments of the county government for the current year, the following appropriations were made:

General County Fund-----	\$34,384.00
Road and Bridge Fund-----	2,000.00
District Court Fund-----	2,000.00
Poor and Pauper Fund-----	500.00

Notice was received from the board of County Commissioners of Lincoln County that they had appointed W. C. McIlvain as Live Stock Inspector, and a motion was duly made and carried that the Board of County Commissioners of Sublette county co-operate with Lincoln County in the appointment and employment of said inspector and to bear an equal part of the expense of said inspector.

There being no further business to come before the Board, an adjournment was taken until the regular monthly meeting in April.
