The Board of County Commissioners met at 10:00 A.M. with Chairman John L. Allen and Com. Vigo N. Miller present. Com. Frank D. Ball absent.

The minutes of the previous meeting were read and approved.

The sealed proposal bids for records embracing Sublette County were opened and upon consideration of the County Commissioners were rejected; whereupon new bids were called for; and bids were received from Voorhees Bros. of Rupert, Idaho, and the Fremont Abstract Loan Co., Lander, Wyoming. After consideration of the same the following resolution was adopted:

"WHEREAS, the proposal from Voorhees Bros. to transcribe all the records from both Lincoln and Fremont Counties for a sum not to exceed \$12000.00 is the lowest and best bid. It is thereupon resolved that the said proposal of Voorhees Bros. be and the same is hereby accepted and the Chairman of said Board is hereby authorized and directed to enter into a contract with the said Voorhees Bros. for the complete transcription of all such records, and that said parties be required to furnish a good and sufficient bond in the penal sum of Six Thousand Dollars for the faithful performance of the terms and conditions of such contract."

The application from the Marbleton State Bank dated April 3, 1923, as depository for County Funds was received and considered; and upon motion duly made and carried the said Marbleton State Bank was designated as a County Depository for the amount of \$5,000.00, upon the bank furnishing sufficient and proper bond or security therefore.

The Surety Bonds, which according to an agreement made at the January meeting to replace the individual bonds were received and approved. Whereupon the bonds furnished the officers signed by individuals were released, with thanks to the bondsmen.

There being no further business to come before the Board they recessed until the first Tuesday in June, and met with R. T. Albert county treasurer, and County Superintendent as Clerk; of the District Boundary Board on Wednesday May 3, 1923.
