

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners, in regular Session assembled that the Board of County Commissioners of Sublette County issue negotiable coupon bonds of said County in the sum of \$10,000.00 for the purpose of paying, redeeming and funding the principal and interest of ^{said} outstanding Certificates of indebtedness, and it is;

FURTHERMORE RESOLVED, That said negotiable coupon bonds shall be issued in the denomination of One Thousand Dollars each and shall be sold to the highest bidder therefore for cash and shall bear interest not to exceed 6% per annum payable semi-annual at the Office of the County Treasurer of Said County, on the first day of January and the first day of July of each year, said Bonds shall be redeemed by the said County in the Following manner TEN PER CENT of total amount issued shall be paid in ten years from the date of issue and ten per cent thereof each year thereafter until the full amount of the said bonds is paid, but said bonds or any part thereof may be redeemed by the said County at any time after five years from the date of their issue, and it is

FURTHERMORE RESOLVED, that the Board of County Commissioners shall give notice of their intentions to issue said bonds, and invite bids therefor by publishing notice thereof in the Pinedale Roundup, The Wyoming Tribune, Cheyenne, Wyo; The Chicago Tribune, Chicago, Ill, and the Daily Bond Buyer, New York City, N. Y.


✓ The Office of the County Clerk report a revenue of \$934.50 collected during the year 1923, same being turned into the General County Fund.
