

Mr. W. W. Bower met with the Board in regard to the right of way across his property and put before them the serious injury that would be done his property by allowing such right of way; for which he had been offered so small a sum for compensation, in lieu of what little benefit the public might derive if the Highway should be allowed; and since certain conditions had arisen since the appraisers report was submitted that changed the aspect of the whole matter, was brought to the attention of the Board, and since the County is in no financial position at this time to buy his right of way it was unanimously voted by the Board to abandon the project entirely for the present time.

Mr. Bower also agreed that he was willing to make any amicable proposition with the Board and Highway Dept. for location and construction of a bridge across Boulder Creek at any time they were ready to build it.

Upon application from Mrs. Viola Rahm for financial aid for her children the Board authorized a \$20.00 per month credit at the Mollring Store.
