April 7, 8, 9, 1925.

The Commissioners met pursuant to adjournment at eleven o'clock A. M. on Tuesday, April 7th, 1925.

Present F. D. Ball, Chairman, Charles Olson and Gust Larson, Commissioners.

The minutes of the last meeting were read and approved.

It was resolved by the Commissioners that the Forest Fund of \$9514.76 available for the year 1925 be apportioned as follows: Five per cent (5%) to the General School Fund and Ninety-five per cent (95%) to the road and Bridge Fund.

The following claims for damages to-wit:
C. G. Jewett \$1500.00; Dan B. Budd \$1000.00; Mrs. Ned Davison \$500.00; due to the establishment of the Big Piney, Daniel Highway were received and placed on file. The Board then appointed Frank Springman and Oscar Beck, of Big Piney, and Ludvig Lindback of Halfway, appraisers to view the premises and fix the damages, if any, of said claimants.

A delegation from Kendall met with the Board in regard to the Green River Road number 8. The Commissioners voted \$750.00 for maintainence on this Road.

~~The County Commissioners have decided to have the Court make the settlement who shall be our County Attorney, and in the meantime Mr. Hopkins has been employed to act until the County Attorney question is settled.~~

The application of Bruce A. Cranor for salary of \$125.00 per month as Deputy Sheriff was approved by the Board.

Henry Williams presented his Certificate of Election, Oath of Office and Bond as Road Supervisor of District No. 3 and the same were approved by the Board.

The Commissioners decided to re-divide the County into four Road Districts instead of the three Districts in existence at the present time. The four districts to be as follows, to-wit:

District Number 1. Beginning at the intersection of West line of Range One Hundred Ten and Township Twenty-seven, running North to South line Township Twenty-nine, thence East to center Range One Hundred Ten, thence North to Green River following Green River to South line Range Thirty-three, thence West to West line Range one hundred eleven, thence North to South line Township Thirty-four, thence West to County line.

Number 2. Beginning at West County line and South line of Township Thirty-four, thence East to West line Range one hundred eleven, thence South to south line Township Thirty-three, thence East to Green River; thence North along Green River to South line Township Thirty-four, thence East to top of divide following meander of divide to South line of Township Thirty-five, thence East to County line.

Number 3. Beginning at South County line and West line Range one hundred ten running North to South line of Township Twenty-nine, thence East to center of Range one hundred ten, thence North to South line of Township Thirty, thence East to West line Range one hundred eight, thence North to New Fork River following New Fork to intersection of Boulder Creek, thence North along Boulder Creek to South line Township Thirty-three, thence East to County line.

Number 4. Beginning at East County line on South Township line Thirty-three running West to Boulder Creek, thence South along said Creek to New Fork River, thence along New Fork River to intersection of West Range line one hundred eight, thence South to North Township line Twenty-nine, thence North to center Range one hundred ten, thence North to Green River following Green River North to South line Township Thirty-four, thence East to divide then following divide to South line Township Thirty-five, thence East to County line.

The Commissioners ordered the County Surveyor to survey a road from the Green River Bridge at A. P. Sommers South to the New Fork Bridge at Charles Olson's. The Road Supervisor was ordered to repair the washes and bad places on this road.

The Commissioners ordered the County Surveyor to survey a road from the New Fork Bridge at Martin Brandt's to Big Piney.

J. C. Clark was appointed as Road Supervisor of Road District No. 4 and a Certificate of Appointment ordered issued upon his filing the oath and Bond required by law.

A petition was presented by the Citizens of Big Piney asking for the appointment of Mrs. Minnie Budd as Justice of the Peace of the Big Piney Precinct. It appearing to the Commissioners that Mrs. Budd would not accept the appointment no action was taken on the petition.

W. H. McDonald presented his Certificate of Election, Oath and Bond as County Surveyor, same being approved by the Commissioners.

The Commissioners ordered that a street light be installed at the corner of the Court house at a cost of \$7.45 to the County.

A Committee met with the Commissioners in regard to distribution of the Forest money. The Commissioners decided not to reconsider their action in apportioning 5% to the School Fund and 95% to the Road and Bridge Fund.

It was resolved by the Commissioners that \$696.80 be transferred from the County
