The Board of County Commissioners met pursuant to adjournment at 2:00 o'clock P. M., July 7, 1925.

Present F. D. Ball, Chairman, Charles Olson and Gust L. Larson, Commissioners.

The minutes of the last meeting were read and approved.

A petition was received by the Board and signed by the <sup>tax</sup>payers of Big Sandy asking for a change in the Lander - South Pass road. The Board authorized the Road Supervisor to spend \$60.00 on this road and also enough lumber to build a bridge over Muddy Creek.

The bonds of W. P. Dew as Treasurer of School District No. 10, and Frances M. Clark as Treasurer of School District No. 2, were approved by the Board.

The application of the A. W. Smith Live Stock Company for rebatement of taxes in the amount of \$262.77 on account of double payment was approved by the Board.

A representative of the State Highway Commission met with the Commissioners in regard to moving a grave from the right of way at the top of the Newfork hill. It appearing upon investigation that the nearest of kin had no objection to the removal, the County Coroner was ordered by the Commissioners to superintend the removal.

The report of the appraisers appointed by the Board to appraise the right of way through Section 16, Township 32, Range 108 West of the Sixth Principal Meridian, granting W. W. Bower damages of \$275.00 with the understanding that the fence, stockway and necessary culvert be put in by other than the claimant, was accepted by the Commissioners.
