

A letter was received from Mr. W. W. Bower protesting against the report of the appraisers awarding \$275.00 damages for right of way throught Section 16, Township 32, Range 108. The Board voted unanimously to stand by the appraisement, which appraisement had been accepted by them at the previous meeting.

A petition was received by the Commissioners from Tax payers of Cottonwood and Halfway asking for the establishment of a County road commencing at a point in Section 24, Township 32, Range 111 West of the 6th Principal Meridian on the State Highway and terminating at a point near Cottonwood lane near Halfway, Township 33, Range 113 West. The Commissioners ordered the County Surveyor to make a survey of this road so that the road may be advertised and established.

The application of Henry Clodius, Agent for Sherman Mullenax for rebatement of Taxes on account of Soldier Exemption in the amount of \$20.78 was approved by the Board.

Mr. W. W. Bower appeared before the Board and contracted to fence the lane where the highway goes through Section 16, Township 32, Range 108 for \$150.00 per mile, all material and labor to be furnished by Mr. Bower.

A petition was received by the Board from Tax payers of South Beaver for the establishment of a County Road. The Commissioners ordered the County Surveyor to view the proposed road and report his estimate at the next meeting of the Board.
