After considerable discussion it was decided by the Board that they would hire some one to look after Mr. Elmore until the next meeting of the Board in April, at which time further action would be taken.

Jack Wall agreed to care for Mr. Elmore until the April meeting of the Board for \$30.00 per month, and this proposition was accepted.

Charles Olson was authorized by the Board to purchase logs for cribbing on the bridges over Green River Southeast of Big Piney.
