The County Board of Equalization met June 27, 28, 29, pursuant to Section 2792 of the Session Laws of 1923 and proceeded to hear and adjust such complaints as were brought before them.

E. G. Mack appeared before the Board in regard to raise in his assessment in number of sheep. The Board voted to approve the assessment schedule as signed by Mr. Mack.

Wm. Woods appeared before the Board in regard to reclassification of his land. The Board voted to let the reclassification stand, making an increased valuation of \$3000.00.

Mrs. M. J. Larson appeared before the Board on behalf of the M. J. Larson Sheep Company. The Board voted to accept the schedule as signed.

The Board voted that the raise in Cattle owned by T. D. O'Neil be cut in half, making a total raise of 75 cattle.

Mr. Floyd Norris appeared before the Board in regard to reclassification of his ranch at Big Piney. It was voted that his land be classified as follows: 200 acres of meadow, 200 acres of pasture and 400 acres of Grazing land.

Mrs. Grace MacGlashan appeared before the Board regarding assessment of lots in Big
