NOTICE OF LOCATION OF COUNTY ROAD.

To all to whom it may concern:

The board of county commissioners have decided to locate a road commencing at the northeast corner of Section 13, T. 32 N., R. 108 W., and running the center line by courses and distances along the Range, Section and subdivision lines as established by government survey.

South 5280 feet, thence north 89 degrees 34 minutes west 1315 feet, thence south 1320 feet, thence north 89 degrees 37 minutes west 3943 feet, to end and intersect with the established county road on the line between Sections 23 and 24, of Township 32 North of Range 108 West, State of Wyoming, County of Sublette.

Said road to have a total width of 60 feet, being 30 feet on either side of and equidistant from said center line, being a parcel of land containing 16 and 1/3 acres.

All objections thereto Claims to Damages by reason thereof must be filed, in writing, with the County Clerk of said County, before noon on the 8th day of March, 1928.

The board of county commissioners of Sublette County, State of Wyoming, have decided to locate a road on the lines between sections 14 and 23, and between sections 15 and 22, connecting with the State Highway at the southwest corner of Section 15, T. 32 N., R. 108 W., and running thence on the center line, south 89 degrees 36 minutes east 5273 feet, thence on the center line, south 89 degrees 36 minutes east 5273 feet, thence south 89 degrees 39 minutes east 5267 feet, terminating at the southeast corner of Section 14, said road to be of a total width of 60 feet, being 30 feet at right angles on each side of and equi-distant from said center line, being a parcel of land containing a total of 14.52 acres.

All objections thereto Claims to Damages by reason thereof, must be filed, in writing, with the County Clerk of said County, before noon on the 8th day of March, 1928;
