April 3rd and 4th, 1928.

The Board of County Commissioners met pursuant to adjournment on April 3rd, 1928. Present, Gust L. Larson and J. Springsted, commissioners. Absent, Charles Olson, Chairman.

Gust L. Larson was chosen Chairman of the meeting.

The minutes of the previous meeting were read and approved by the Board.

The report of the County Treasurer and County Clerk were presented to the Board and ordered filed.

Knute Jomen, James Jensen and Henry Williams appeared before the Board, asking for an appropriation for the Eastfork Lane. Three Hundred Dollars was appropriated for this work.

R. W. Hopkins appeared before the Board regarding the condition of the County Road from Big Sandy to Elkhorn and from Elkhorn to the Sweetwater County line, and suggested that some action be taken to remedy the same. The Commissioners instructed the road supervisor to inspect the road and make it passable, also to ascertain and report the conditions.

L. E. Cooper appeared before the Board, asking an appropriation for the New Fork Lake road. The Board appropriated \$100.00 for this road.
