The Commissioners of the Boulder Irrigation District having heretofore certified to the Board of County Commissioners of Sublette County, Wyoming, the assessment roll of said District for the year 1928, as it appears on pages _____ to _____ inclusive, of the volume designated _____ correctly showing the name of the owner, if know, together with the desceiption of each lot, tract, and easement of land within the district, the aggregate amount of benefits confirmed by the Court, against the same; the name of all corporations assessed, together with the aggregate assessments levied against such corporations respectively; and the amount assessed against each lots, tract, easement and corporation in the said District to meet the yearly current expense and to meet the interest and principal, if any, on the bonded indebtedness of the district for the current year.

All assessments to meet the principal, if any, and interest on the bonded indebtedness of the district for the current year, are apportioned on the aggregate assessment of benefits last confirmed by the Court.

All assessments for the current yearly expenses of said District, are based upon irrigable acreage and are uniform as to irrigable lands receiving a maximum apportionment of water from said District, and as to irrigable lands receiving less than such maximum apportionment, such assessments bears the same proportion as the amount of water apportioned to such lands, bears to the maximum apportionment of water to other lands in the district.

IT IS THEREFORE ORDERED by said Board of County Commissioners that the assessment against lot, tract, easement and corporation as shown in said assessment roll, be and the same is hereby levied against the same; and that said assessment roll be and it is hereby certified to the County Assessor, who shall cause the same to be placed upon the tax roll of said County to be collected as provided by law.
