The reports of the County Treasurer and County Clerk were presented to the Board and ordered filed.

The County Treasurer was authorized to call in Certificates of Indebtedness from #2024 to and including #2270, in the amount of \$10644.59, also to call in all outstanding Certificates on the 10th of December.
