

OFFICIAL COMMISSIONER'S PROCEEDINGS

August 5th & 6th, 1929.

The Board of County Commissioners met on August 5th, 1929, pursuant to adjournment with Chairman Gust L. Larson and Commissioners James P. Jensen and J. W. Montrose present.

The minutes of the previous meeting were read and approved.

On motion of Commissioner James P. Jensen, seconded by Gust L. Larson, the following resolution was adopted by the unanimous vote of the members of the Board:

Whereas under the provisions of Section 9 of Chapter 129 of the Wyoming Session Laws of 1927, this Board is authorized and required to make a levy of one-twentieth (1/20) of a mill on all taxable property for the credit of the Department of Commerce and Industry:

Now Therefore Be It Resolved that, for the purpose of complying with said statutory requirement and purpose, there is hereby levied upon all taxable property within the County of Sublette, for the year 1929, one-twentieth of one mill (.05) Mill), the money collected by reason of said levy to be paid by the County Treasurer as by said statute provided.

On motion of Commissioner Montrose, seconded by Commissioner, Jensen, the following orders were made and adopted:

The Commissioners of the New Fork Lake Irrigation District, having heretofore certified to the Board of the County Commissioners of the County of Sublette, State of Wyoming, the assessment roll of said District for the year 1929, as it appears on pages \_\_\_\_\_ to \_\_\_\_\_ inclusive, of the volume designated \_\_\_\_\_ correctly showing the name of the owner, if known, together with the description of each lot, tract and easement of land within the district, the aggregate amount of benefits confirmed by the Court, against the same; the name of all Corporations assessed, together with the aggregate assessments levied against such corporations respectively; and the amount assessed against each lot, tract and easement of land and against each corporation in the District to meet the interest on the bonded indebtedness of the District for the current year, all of which assessments are apportioned on the aggregate assessment of benefits last confirmed by the Court.

IT IS THEREFORE ORDERED by said Board of Commissioners that the assessment against each lot, tract and easement, and corporation, as shown in said Assessment roll, be and the same is hereby levied against the same; and that said assessment roll be and the same is hereby certified to the County Assessor, who shall cause the same to be placed upon the tax roll of said County to be collected as provided by law.

The Commissioners of the Boulder Irrigation District having heretofore certified to the Board of County Commissioners of the County of Sublette, State of Wyoming the assessment roll of said District for the year 1929 as it appears on pages \_\_\_\_\_ to \_\_\_\_\_ inclusive of the volume designated \_\_\_\_\_ correctly showing the name of the owner, if known, together with the description of each lot, tract and easement of land within the District the aggregate assessment of benefits confirmed by the Court against the same; the name of all corporations assessed together with the aggregate assessment levied against such corporation respectively; and the amount assessed against each corporation in the District and against each lot, tract and easement of land therein for current expense and to meet the interest on the bonded indebtedness of the District for the current year. All assessments to meet the principle and interest on the indebtedness of the District for the current year are apportioned on the aggregate assessment of benefits last confirmed by the Court. All assessments for current expense are based upon irrigable acreage and are uniform as to the irrigable lands receiving a maximum apportionment of water from said District, and as to irrigable lands receiving less than such maximum apportionment such assessment bears the same proportion as to the amount of water apportioned to such lands bears to the maximum apportionment of water to other lands in the District.

And it being shown to the satisfaction of said County Commissioners that there is an existing agreement between the land owners under the Berkhalter Ditch and the balance of the District to the effect that the lands under said Berkhalter Ditch should be assessed separately for maintenance on said Berkhalter Ditch and its laterals; and it further appearing that the holders under said Berkhalter Ditch should not be assessed for maintenance on the main canal below the headgate of said Berkhalter Ditch.

IT IS THEREFORE ORDERED by said Board of County Commissioners that the assessment against each lot, tract and easement and corporation as shown in said assessment roll and as shown on the original estimate and budget of the Commissioners of said District be and the same is hereby levied against the same in the manner and on the basis as shown on said assessment roll and in said estimate and budget of said Commissioners; and that said assessment roll and budget as herein mentioned be and it is hereby certified to the County Assessor who shall cause the same to be placed upon the tax roll of said County to be collected as provided by law.
