

PRIMARY ELECTION PROCLAMATION

TO THE VOTERS OF SUBLETTE COUNTY, WYOMING:

IT IS HEREBY ORDERED AND PROCLAIMED, That a Primary Election will be held throughout Sublette County, in the State of Wyoming, on Tuesday, August 19th, A. D. 1930, for the purpose of nominating candidates of political parties for all offices which are to be filled by the direct vote of the people at the General Election to be held on November 4th, A. D. 1930 and for the election of Party Committeeman as provided by Chapter 159 of the 1920 Wyoming Compiled Statutes and laws amendatory thereto.

The Board of County Commissioners of the County of Sublette, State of Wyoming, met in special session, after due notice in accordance with law, on the 23d day of September, A. D. 1930, convening at the hour of 2:00 o'clock P. M., there being present:

Gust L. Larson, Chairman
 James P. Jensen, Commissioner,
 J. W. Montrose, Commissioner,

and C. C. Feltner, County Clerk, when the following business was transacted:

Commissioner James P. Jensen introduced the adoption of the following resolution which was duly seconded by Commissioner J. W. Montrose.

"Be it resolved by the Board of County Commissioners of the County of Sublette, sitting in special session at Pinedale, Wyoming, this 23d day of September, A. D. 1930, that the following question be submitted to the qualified electors of Sublette County, Wyoming, at the general election at all the regular election districts of Sublette County, to be held on the 4th day of November, A. D. 1930:

'Shall the bonds of Sublette County, Wyoming, be issued in an amount not exceeding Thirty Thousand Dollars (\$30,000.00), bearing interest at a rate of interest not to exceed six (6) per centum per annum, for the purpose of constructing and equipping a County Court House and Jail, said Court House and Jail to be located in the Town of Pinedale, Sublette County, said bonds to be due in twenty (20) years with option of prior payment after ten (10) years?'

The official ballot to be used in voting upon the question above submitted shall be printed and furnished by the County Clerk to the Judges of the election, to be by them furnished to the voters and shall be in the following printed form:

Question Submitted:

Shall the bonds of Sublette County, Wyoming, be issued in an amount not exceeding Thirty Thousand Dollars (\$30,000.00), bearing interest at a rate of interest not to exceed six (6) per centum per annum, for the purpose of constructing and equipping a County Court House and Jail, said Court House and Jail to be located in the Town of Pinedale, Sublette County, said bonds to be due in twenty (20) years with option of prior payment after ten (10) years?
