ELECTION PROCLAMATION

At the general election to be held in the County of Sublette, in each and every polling precinct thereof, on Tuesday, the 4th day of November, A. D. 1930, between the hours 9:00 o'clock A. M. and 7:00 o'clock P. M., there shall be submitted to the qualified electors of said County of Sublette, the following question:

Shall the bonds of Sublette County, Wyoming, be issued in an amount not exceeding Thirty Thousand Dollars (\$30,000.00), bearing interest at a rate of interest not to exceed six (6) per centum per annum, for the purpose of constructing and equipping a County Court House and Jail, said Court House and Jail to be located in the Town of Pinedale, Sublette County, said bonds to be due in twenty (20) years with option of prior payment after (10) years?
