Application of Mrs. Mary Healey for Mother's Pension was approved in the amount of \$25.00 per month for the year 1931. The bonds of Jennie Fronk, Treasurer School District No. 5 and Lena A. Pape, School District No. 6 were approved; also bonds of the Lincoln Planing Mill & Lumber Company for general construction on Court House and Rock Springs Plumbing Co. for plumbing contract on Court House.

Application of Edward Levi Herring for Old Age Pension was presented. No action taken.

Petition for abatement of taxes in the amount of \$245.43 by Thomas Jefferson was rejected.

Application of the Rock Springs National Bank for deposit of County funds in the amount of \$5,000.00 was approved.

The offer of the City of Rock Springs to sell to Sublette County four used jail cells for the sum of \$300.00 f.o.b. truck at Rock Springs was accepted.

An agreement was entered into with D. D. Joslyn, representative of Austin-Western Road Machinery Company for the delivery of No. 25 Austin Dual Drive Motor Grader at a price of \$5,208.00, f.o.b. Rock Springs, Wyoming, machine to give satisfaction under actual tests both as a road maintainer and a road constructing machine.

It appearing that the duly elected and qualified Justice of The Peace for Big Piney Justice District is no longer a resident of Sublette County, it was ordered that the office be declared vacant. On petition of a number of the electors, H. E. Griggs was appointed to the office of Justice of the Peace, Big Piney Justice District.

The report of Vigo N. Miller, Viewer of South Beaver Road No. 51 was approved and the road ordered surveyed.

The petition of C. P. Fitzpatrick et al. for the establishment of a road commencing at a point two hundred feet east of the south quarter corner of Section 34-27-113 and running thence northerly about 20 miles and connecting with the county road near the town of Big Piney was read and approved and William Payne was appointed Viewer.

The petition of B. R. Bain et al. for the establishment of a road commencing at Merna and running thence due north to northwest corner of Section 16-35-113 was read and approved with the understanding that width of road-way would be 80 feet, and Philip Burch was appointed Viewer.

Appraisers on the Forest Highway Projects 3-A-4 and D-1 were appointed as follows: D. H. Scott, Fred Pape, and T. D. O'Neil.

L. C. Nelson and George Gilligan were authorized to expend \$300.00 on East Fork-Sand Springs Road.

On motion duly made and carried the following resolution was unanimously adopted:

RESOLUTION
