The Board of County Commissioners of Sublette County, Wyoming, met in regular session at ten o'clock A. M., September 1, 1931, there being present: James P. Jensen, Chairman, Arthur Mocroft and J. W. Montrose, Commissioners.

The following proceedings were had and taken:

The petition of J. J. Albano, et al. for the extension of the Merna Road beginning at the end of said Merna road and running up north Horse Creek to a point on the forest boundary about one-half mile east of the Sherman Ranger Station, was received and approved and Austin Richardson was appointed viewer.

On motion duly made the following were appointed Appraisers of New Fork-Marsh Creek Road: Lee Thompson, William Alexander, and R. E. Clark.

A petition was presented asking for the appointment of Walter Gurney as janitor of the new Court House, but as this position had already been filled at the last preceding meeting, no action was taken thereon.

The County Clerk was instructed to advertise for bids on 50 tons of coal.

It was ordered that \$1800.00 be transferred from the Court fund to the General County Fund.
