On motion duly made and carried, the following were appointed Appraisers on Change "A" of Dell Creek Road No. 10; Keith Culbertson, George Franz, and Arthur F. Pape.

Petition for the establishment of a county road commencing near the Southeast corner of Section 15, T. 31 N., R. 114 W., and running thence Northwesterly to the Northeast corner of Section 16; thence Westerly to the Northwest corner of Section 18, and terminating at the Northwest corner of Section 18, T. 31 N., R. 114 W., was presented by John C. Budd, et al; the petition was accepted and John C. Budd appointed viewer.

Petition for the establishment of a county road commencing on Green River Road No. 8 at a point near the Southwest corner of Section 3, T. 34 N., R. 110 W., and running thence Easterly a distance of one mile, was presented by Carroll R. Noble, et al; the petition was accepted and Carroll R. Noble appointed viewer.

All things having been done in conformity with the statutory requirements for the establishment of the Boulder Lake Road No. 52, and it appearing that a petition for the establishment of said road, the Appointment of, and Order to Viewer, and Viewer's Report thereon, and a plat and notes of an actual survey, certified by the surveyor, are on file in the office of the County Clerk; and it further appearing that Notice of the Establishment of said road has been advertised, as by law required, in three successive issues of the Pinedale Roundup, a weekly newspaper published in Sublette County, and all claims for damages by reason of the establishment of said road having been paid, --on motion duly made and carried it was ordered that said Boulder Lake Road No. 52 be established as a County Road.

All things having been done in conformity with the statutory requirements for the establishment of the Pinedale-East Road No. 55, and it appearing that a petition for the establishment of said road, the Appointment of, and Order to Viewer, and Viewer's Report thereon, and a plat and notes of an actual survey, certified by the surveyor, are on file in the office of the County Clerk; and it further appearing that Notice of the Establishment of said road has been advertised, as by law required, in three successive issues of the Pinedale Roundup, a weekly newspaper published in Sublette County, and no claims for damages having been presented by reason of the establishment of said road, --on motion duly made and carried it was ordered that said Pinedale-East Road No. 55 be established as a County Road.

There being no further business the Board duly adjourned until the next regular meeting date, October 3, 1933.

The Board of County Commissioners of Sublette County, Wyoming, met in special session at ten o'clock A. M., August 7th, 1933, there being present: Arthur Mocroft, Chairman, and James P. Jensen and E. A. Richardson, Commissioners, and C. C. Feltner, County Clerk.
