The Board of County Commissioners of Sublette County met in special session on August 7th, 1934 and 10:00 o'clock A. M., there being present: Arthur Mocroft, Chairman and James P. Jensen and E. A. Richardson, Commissioners, and C. C. Feltner, County Clerk.

The minutes of the last regular meeting and special meeting were read and approved.

Petition for abatement of taxes was presented by Henry A. Schrader in the amount of \$5.56 and allowed.

The petition of Walter Lindback, et al for the establishment of a road commencing on Cottonwood Road in Section 2, T. 33 N., R. 113 W., 6th P. Larson was appointed Viewer.
