The Board of County Commissioners of Sublette County met pursuant to adjournment on December 4, 1934 at 10:00 o'clock A. M., there being present: Arthur Mocroft, Chairman and Austin Richardson, Commissioner, and C. C. Feltner, County Clerk.

The application of the State Highway Department for the establishment of the Pinedale-Farson road having been filed and notice of proposed location having been advertised as required by law; and it appearing that claims for damages by reason of the establishment of said road have been filed in the office of the County Clerk, on motion duly made and carried the following were appointed appraisers:

John W. Bloom, C. F. Webb and Frank Fear;

and Monday, December 10, was set as the date on which appraisal is to be made.

The application of Samuel S. Sage for an Old Age Pension was received and referred to James P. Jensen for investigation.
