On motion duly made and carried the County Clerk was ordered to issue Retail Liquor Licenses to Walter F. Yarger and Wm. C. Chall.

Reports of earnings of R. T. Albert, Assessor, W. H. Bolinger, Justice of the Peace, and C. C. Feltner, County Clerk and Clerk of Court, were approved.

On application of Faren C. Faler, County Treasurer, Eunice Healey was appointed Deputy County Treasurer, at a salary of not to exceed \$75.00 per month, and bond of \$5000.00 approved and ordered filed, together with oath of office.

Bonds and Oaths of Office of H. A. Thompson and Oscar D. Evans as Deputy Assessors were approved and ordered filed.

On motion duly made and carried it was ordered that all County purchases be made by requisition through the purchasing Agent, and that claims for purchases made in any other manner be not paid after this date.

After a lengthy discussion it was ordered that \$1,000.00 be set aside to be used as a contribution to a hospital building fund, and that the Board go on record as sponsoring a W.P.A. project for the construction of said hospital provided sufficient additional funds are contributed to assure completion of the building.

The County Clerk was authorized to dispose of all blank forms not necessary for County business, as an economy measure.

There being no further business the meeting adjourned until next regular meeting date, April 5, 1938.
