A special meeting of the Board of County Commissioners of Sublette County, Wyoming was held on the above date, there being present James Jensen and Jas. F. Mickelson, Commissioners and C. C. Feltner, County Clerk.

On motion duly made and carried James Jensen was appointed temporary chairman.

The report of the appraisers on the Kemmerer - Big Piney road No. Sb 2 (F.A.P. 158 A (3) 1939) was read, wherein it appeared that the following damages were allowed:

Anderson L. McGinnis,.....\$305.00
Beneficial Oil Company,..... Nil

On motion duly made and carried the allowance to Anderson L. McGinnis was approved and the Beneficial Oil Company was allowed a total of \$50.00 to cover all damages by reason of the establishment of said road.

It appearing that Notice of Location of Kemmerer-Big Piney road No. Sb 2 (F.A.P. 158 A (3) 1939) was duly advertised in the Big Piney Examiner, a weekly newspaper published in Big Piney, Sublette County, Wyoming, and thereafter that this Board appointed three appraisers to appraise the claims for damages by reason of the establishment of said road, and all damages assessed by said appraisers having been paid; and all other necessary action having taken according to the requirements of law, - on motion duly made and carried it was ordered that said Kemmerer - Big Piney Road No. Sb 2 (F.A.P. 158 A (3) 1939) be duly established as a public road.

There being no further business the meeting adjourned.
