OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
November 6th, 1939.

The Board of County Commissioners met in special session on the above date as required by the 1939 Budget Act.

There were present Chairman James Jensen, Commissioners Jas. F. Mickelson and Ludvig Lindback and County Clerk Faren C. Faler.

County Budget officer Faren C. Faler presented the proposed 1940 Budget as required by Section 5, Chapter 87 of the Session Laws of Wyoming, 1939.

The said proposed budget was carefully studied and some changes made. On motion regularly made, seconded and carried the budget was approved, a copy ordered filed in the office of the County Clerk as a part of the official records of the Board of County Commissioners.
