Bonds of Ardis L. Birtwistle as Deputy County Treasurer and Lawrence W. Shaul as District No. 3 Deputy Assessor were regularly approved.

A petition for the establishment of a County road in the Hoback Basin was presented by Shel E. Baker and others. The petition was accepted and proceeding ordered started to secure the right-of-way.

The time arrived for the hearing on the budget. A delegation representative of ranchers, business men and corporations was present. They unanimously requested the adoption of the budget as advertised. The Board, therefore, regularly adopted the following Resolution:

APPROPRIATION RESOLUTION

WHEREAS, on the 20th day of December, 1943, Faren C. Faler the budget making authority, prepared and submitted to the Board a county budget for the year 1944; and

WHEREAS, such a budget was duly entered at large upon the records of this Board and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Pinedale Roundup, a legal newspaper published and of general circulation in the county for three consecutive weeks prior to the 7th day of February, 1944; and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in said proposed budget, all of which more fully appear in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the year 1944.

BE IT FURTHER RESOLVED that the following appropriations be made for the year 1944 and that the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.
