

## OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
February 5, 1945

The Board met on the above date as required by law to hear protests on the proposed 1945 budget. Those present were Chariman Carroll R. Noble, Commissioner James F. Mickelson, Commissioner James Jensen and their clerk, Helen Atwood.

There were no protests made at the time and place of public hearing on the proposed budget for the year 1945. The following resolution was then regularly adopted:

## APPROPRIATION RESOLUTION

WHEREAS, on the 18th day of December, 1944 Helen Atwood, the budget making authority, prepared and submitted to the Board a county budget for the year 1945; and

WHEREAS, such a budget was duly entered at large upon the records of this Board and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Big Piney Examiner, a legal newspaper published of the general circulation in the county for three consecutive weeks prior to the 5th day of February, 1945 and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in said proposed budget, all of which more fully appear in the minutes of Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the year 1945.

BE IT FURTHER RESOLVED, that the following appropriations be made for the year 1945 and that the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.
