OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS.

August 5, 1947.

The Board met on the above date with those present being Chairman James Jensen, Commissioners James P. Jensen and Carroll R. Noble and County Clerk H. H. Summers

The minutes of the previous meeting were read and approved.

Reports of the County Officers were approved.

Mrs. Elton Cooley and James Harrower met with the Board in regard to a place to display relics and papers of the Historical Society.

The Bonds of Richard D. Hecox as Treasurer School District No. 6, Robert Lozier as Treasurer School District No. 2 and Merle C. Widick Treasurer School District No. 1 were approved by the Board.

Mr. Clifton Fear and William McGinnis met with the Board in regard to a bridge across Green River.

Mr. E. G. Mack met with the Board in regard to a road in the Basin.

Mr. Carl Jorgensen met with the Board in regard to Fish and Game Commission problems.

The Board approved the appointment of R. S. Carlson as cattle inspector.

The Clerk was instructed to advertise for bids on coal for the Court House.

A petition was presented to the Board by John Ball and others to establish a road commencing at NE Corner of Sec. 28 and running East one mile and terminating at NW Corner of Section 26, all in T. 32 N., R. 108 W. 6th P. M. Mr. Chris Berg was appointed Viewer of the road.
