January 6, 1948

The Board met on the above day. Those present were Commissioners James Jensen, Carroll R. Noble and James P. Jensen and their Clerk, H. H. Summers.

The minutes of the previous meeting were read and approved.

The Forest Reserve Fund was ordered distributed 80% to Roads and Bridges and 20% to Schools.

Pursuant to Chapter 32 Section 406 Wyoming Compiled Statutes 1945, a School Poll Tax of \$2.00 was levied by the Board for each and every person in Sublette County between the ages of 21 years and 50 years inclusive for County School Purposes.
