The Board met in regular session on this date with all present. The minutes of the previous meeting were approved as read. Reports of the various county officers were approved and filed. Rebate Order No. 126 in the amount of \$14.01 was issued to Robert L. Miller. Having been advertised and no protests filed, Malt Beverage Permits were issued to Ed. J. Keranan, Bondurant, Wyo., and Earl Steele, Boulder, Wyoming.

It was regularly moved, seconded and carried that the following resolution be approved:

WHEREAS, due to unanticipated requirements it is now necessary to transfer the sum of \$300.00 from the Cash Reserve Fund to the County Treasurer, Fund to meet the necessary requirements of this account for the balance of the fiscal period, expiring June 30, 1950, and WHEREAS, Notice of Public Hearing has been published and a copy and notice was mailed to the State Examiner in accordance with the Wyoming Statutes, and no protests filed, NOW, THEREFORE, BE IT RESOLVED, that the sum of \$300.00 be transferred to the County Treasurer Fund from the Cash Reserve Fund.

Resolution

WHEREAS, the Board of County Commissioners of the County of Sublette, is desirous of taking advantage of the Provisions of Chapter 25, Session Laws of Wyoming, 1949, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows: Beginning at the end of State Project 2304 in Section 4, T. 30 N. R. 109 W. of the 6th P.M. in Sublette County, thence easterly 10.951 miles to a junction with State Highway No. 187 in Section 31, T. 31 N. R. 107 W or as far as available funds will permit.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of the said Board.
