OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS.Pinedale, Wyoming
September 5, 1950

The Board met in regular session on this date with Commissioners Carroll R. Noble, James Jensen and Donald W. Jewett and their clerk, H. H. Summers present.

The minutes of the previous meeting were approved as read.

Reports of the various County Officers were approved and filed.

The bond of Floyd H. Wassenberg as Treasurer of Southwest School District in the amount of \$15000.00 was approved.

The bond of Donald Sparks as Treasurer of School District No. 3 in the amount of \$4500.00 was approved.

The bond of B. R. Dockham as Treasurer of School District No. 5 in the amount of \$2000.00 was approved.

Having been advertised and no protests filed, a Retail Liquor License was issued to Geo. Grassell.

A report of Examination of Sublette County, Wyoming as of the close of business June 30, 1950 was received from Norris E. Hartwell, State Examiner, Cheyenne, Wyo. and we, the undersigned, constituting a quorum of the Board of County Commissioners of Sublette County, Wyoming acknowledge receipt of the Report of Examination as above noted, made under the supervision of the State Examiners Department. After careful consideration of this report, we concur with the Examiner in the suggestions he has made, and we have requested the officials to adjust their methods in compliance therewith.
