

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
May 1, 1951

The Board met in regular session on this date with Commissioners James Jensen, Donald W. Jewett and Philip Marincic and their Clerk H. H. Summers present.

The minutes of the previous meeting were approved as read.

Reports of the various County Officers were approved and ordered filed.

Having been advertised and no protests filed, a Retail Beverage Permit was issued to Ed. J. Kieranen of Bondurant, Wyo. of Rock Springs

The Application for Deposit of Public Funds of Rock Springs National Bank, Rock Springs was considered by the Board and the Rock Springs Nat. Bank was designated a County Depository for Sublette County.

The Bond of Paul Allen in the amount of \$2000.00 as Town Clerk and Treasurer of Town of Pinedale was approved.

The Bond of Norman Barlow in the amount of \$3000.00 as Treasurer of New Fork Lake Irrigation Co. was approved.

The Welfare Budget for 1952 was approved in the amount of $1\frac{1}{2}$ mills for General Welfare and .770 mills for General Welfare Health.

Mr. Hilton of the Highway Department met with the Board in regard to roads.

Having been moved, seconded and carried, the following resolution was approved:

RESOLUTION.

WHEREAS, the Board of County Commissioners of the County of Sublette, is desirous of taking advantage of the provisions of Chapter 99, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Building of a bridge across Green River in Lots 7, 8, 9 and 10, Section 28, T. 29 N. R. 111 W.
NOW THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with the said Commission covering said improvements in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; and that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
