October 7, 1952

The Board met in regular session on this date with all members present.

The minutes of the previous meetings were approved as read.

The reports of the various county officers were approved and ordered filed.

The following resolution was unanimously adopted, all the County Commissioners being present and all voting in favor thereof:

## RESOLUTION.

WHEREAS the Board of County Commissioners of Sublette County, Wyoming, deems it is to the public interest that a driveway to be known as the Pole Creek Driveway be established,

NOW, THEREFORE, be it resolved by said Board that proceedings for establishing of said driveway be initiated, the description of said driveway is as follows: to wit:

Beginning at the center of Section 19, T. 33 N., R. 108 W., thence northerly to the NW corner of the SW $\frac{1}{4}$ SE $\frac{1}{4}$ , Sec. 18, this part of the driveway being 100 feet in width all to the west of this line; thence northerly from the NW corner of the SW $\frac{1}{4}$ SE $\frac{1}{4}$ , Sec. 18 to the center of Sec. 18, thence northeasterly to the SW corner of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ , Sec. 18; thence easterly to the SE corner of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ , Sec. 18; thence northerly to the NE corner of Sec. 7; thence westerly to the SW corner of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ , Sec. 6; thence northerly to the NW corner of NE $\frac{1}{4}$ NE $\frac{1}{4}$ , Sec. 6, T. 33 N., R. 108 W, thence northerly to the center of the SE $\frac{1}{4}$  of Sec. 31, T. 34 N., R. 108 W, this part of the driveway being 100 feet in width with 50 feet being on either side of this line.

WHEREAS the Board of County Commissioners of Sublette County, Wyoming, deems it is to the public interest that a road to be known as the Ball Cutoff Road be established,

NOW, THEREFORE, be it resolved by said Board that proceedings for establishing of said road be initiated, the description of said road is as follows: to-wit:

Commencing at Station 3 of County Road No. 30C in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ , Sec. 13, T. 34 N. R. 113 W, thence proceeding S 30° 49' E 504.5 feet, thence S 53° 24' E 64.5 feet; thence South 1329 feet; thence S 01° 07' W 707.5 feet; thence S 57° 27' E 305.5 feet; thence S 21° 18' E 446 feet; thence S 41° 00' E 261 feet; thence S 01° 05' E 370 feet; thence S 06° 08' E 302 feet; thence S 38° 56' W 383 feet; thence S 04° 47' W 492 feet; thence S 26° 57' E 315 feet; thence S 57° 32' W 301 feet, terminating at Station 25 of County Road No. 38B in the NW $\frac{1}{4}$ SE $\frac{1}{4}$  Section 24, T. 34 N. R. 113 W 6th P.M. Said road to be 100 feet in width.
