March 3, 1953

The Board met in regular session on this date with all members present.

Bond of Charles Healea in the amount of \$4000.00, Treasurer School District No. 5, was approved.

Bond of Rosalie Hockett in the amount of \$500.00, Notary Public was approved.

Rebate Order No. 137 in the amount of \$19.23 on 1952 taxes was approved.

The following Resolution was unanimously adopted, all the County Commissioners being present and all voting in favor thereof:

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Sublette is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows: Grading, drainage, treated timber bridges and miscellaneous work in Sections 13 and 24, T. 34 N. R. 113 W 6th P.M. approximately 1½ miles, Known as Ball Cut off Road.

NOW, THEREFORE, be it resolved by said Board:

That the Board enter into written agreement with said Commission covering said improvements in accordance with a contract therefore, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract of said Board.
