## OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

September 7, 1954

The Board met in regular session on this date with all members present.

The reports of the various County Officers were approved and ordered filed.

The minutes of the previous meeting were approved as read.

George Franz was appointed to the County Welfare Board to fill the unexpired term of Nels Christensen, Deceased.

Sally Budd of Big Piney was granted the County Scholarship to the University of Wyoming.

The Board of Herman C. Jensen, Treasurer Sublette County Memorial Hospital, \$5000.00 was approved.

Having been moved, seconded and carried the following resolution was adopted:

## RESOLUTION

The WHEREAS, in the Board of Commissioners of Sublette County, Wyoming on January 6, 1953 Declared as a County Road that portion of the Willow Lake Road running through private lands, and

The reports of the various County

2. WHEREAS, The Wyoming Game and Fish Commission is now constructing under appropriate permit that portion of the Willow Lake Road (3.68) miles running across Bridger National Forest and State lands from a point on Willow Lake to a point near the West Quarter Corner of Section 34, T. 35 N. R., 109 W., and

3. WHEREAS, the Wyoming Game and Fish Commission has surveyed and proposes to construct the remaining portion of the Willow Lake Road (4.260 miles) extending from a point near the West Quarter Corner of Section 22, T. 34 N. R. 109 W., and

4. WHEREAS, ALL the lands traversed by the road described in paragraph 3 above are unappropriated and unreserved public lands, and

5. WHEREAS, Section 2477 of the United States Revised Statutes provides that the right of way for the construction of Highways over Public Lands, not reserved for public uses, is granted upon the establishment or construction of the highway in accordance with any of the modes described or recognized by the Laws of the State,

NOW THEREFORE BE IT RESOLVED, that the road described in paragraph 3 above and shown in detail on a map on file with the County Clerk be declared established and a plat of same be placed in road plat book with proper notations of the proceedings of said Board in relation to the establishment.
