OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS.

Pinedale, Wyoming  
October 5, 1954

The Board met in regular session on this date with Commissioners Donald W. Jewett and Donald Sparks and their clerk H. H. Summers, present.

The reports of the various County Officers were approved and ordered filed.

The minutes of the previous meeting were approved as read.

The bonds of Percy Edwards \$1000.00, Special Deputy Sheriff and Deputy County Livestock Inspector and George W. Nicholas, Treasurer School SouthWest School District \$15,000.00 were approved.

Reduction Order No. 175, Robert F. Young, \$16.59; No. 176, Pete Frullo, \$24.57; and Thurston Doyle No. 176 \$1.60 were issued.

Acceptance Agreement No. 188, State of Wyoming, \$159.40 and No. 189, Town of Pinedale, \$50.00 were approved and the money ordered turned into the County Treasury.

Having been moved, seconded and carried the following resolution was adopted:

RESOLUTION.

WHEREAS, the Board of County Commissioners of the County of Sublette is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Willow Lake Road. From the North Corporate limits of the Town of Pinedale in the SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Sec. 33, T. 34 N. R. 109 W., thence northeasterly to a point in the SW $\frac{1}{4}$  of Sec. 22, T. 34 N. R. 109 W. approximately 2.6 miles. Grade, drain and surfacing.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvements in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
