The Board met on this date with all members present.

Donald Sparks was regularly elected Chairman of the Board for the next two years.

The Bonds of the following County Officers and Deputies having been approved and subscribed to the required oath for their respective offices were, on motion regularly made and seconded and carried declared qualified and approved.

The following Officers and Deputies were declared qualified and sworn in to their respective offices:

Hazel Lawes, County Treasurer; Hazel Werner, County Assessor; Morris C. Horton, Sheriff; John S. Mackey County and Prosecuting Attorney; Rosalie E. Hockett, County Superintendent of Schools; Francis W. Tanner, County Coroner; Harmon Shannon, Justice of Peace; Bert Reinow, Justice of Peace; James P. Jensen, Justice of Peace; Hazel P. Bloom, Deputy County Clerk and Deputy Clerk of Court; Wm. E. Carr, Undersheriff; Ted Wiederanders, Deputy Sheriff, Jailer and Janitor.

Morris C. Horton was appointed County Livestock Inspector, and Ted Wiederanders was appointed Deputy County Livestock Inspector and Wm. E. Carr was appointed Deputy County Livestock Inspector.

George Franz was appointed to the County Welfare Board for a period of three years and Philip Marincic was appointed to the County Welfare Board for his term as Commissioner.

The Sheriff Morris C. Horton was appointed custodian of the Court House.

The County Clerk, H. H. Summers was appointed County Purchasing Agent.

Victor McGinnis, James Shipley and E. W. McNinch were appointed Weed and Pest Commissioners to serve for the year, 1955.

The Forest Reserve Fund was ordered distributed 80% Road and Bridge and 20% to Schools.

Pursuant to Chapter 32, Section 406 of the 1945 Wyoming Compiled Statutes a School Poll Tax was levied by the Board on every person in Sublette County between the ages of twenty-one years and fifty years inclusive in the amount of \$2.00.

Assessment Districts were established the same as those established January 3, 1950 and described in the Board minutes of that day in Book 1 of Commissioners Proceedings at page 476.

On motion regularly moved, seconded and carried the Pinedale Roundup was designated the Official County Newspaper for the next two years.
