OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
April 5, 1955

The Board met on this date with all members present.

The reports of the various County Officers were approved and ordered filed.

The minutes of the previous meeting were approved as read.

Acceptance Agreement No. 220, State of Wyoming, \$108.19 and No. 201, Town of Pinedale, \$50.00 were approved and money ordered turned into the County Treasury.

Bond of Robert C. Thompson, Deputy County Assessor, \$1000.00 was approved.

On motion regularly moved, seconded and carried the State Bank of Big Piney and the Rock Springs National Bank were approved as depositories for county funds not to exceed the amount of the securities pledged respectively by them.

On motion regularly moved, seconded and carried the following resolution was adopted:

RESOLUTION

IN THE MATTER OF THE APPLICATION )	BOARD OF COUNTY COMMISSIONERS
OF EL PASO NATURAL GAS COMPANY )	OF SUBLETTE COUNTY, WYOMING
FOR RIGHT-OF-WAY )	5TH DAY OF April 1955

Now on this 5 day of April, A. D., 1955, came on to be heard the application of El Paso Natural Gas Company, a corporation duly incorporated, organized and existing under the laws of the State of Delaware, for the right and privilege to lay down, construct, operate and maintain pipelines for the transportation of gas, water, and oil, and, in connection therewith, telegraph, telephone and power lines and appurtenances thereto, across, on, along, in and under the roads and highways and the streets and alleys of unincorporated cities and town and other public grounds of Sublette County, Wyoming.

And the Board of County Commissioners having fully considered the same, IT IS ORDERED ADJUDGED AND DECREED that the said El Paso Natural Gas Company, its successors and assigns, or either of them shall be and have, and are hereby granted the right and privilege to lay down, construct, operate and maintain pipelines for the transportation of gas, water and/or oil, and in connection therewith telegraph, telephone and power lines and appurtenances thereto across, on, along, in and under the public roads and highways over which the Board of County Commissioners has control or authority, and the streets and alleys of unincorporated cities and town and other public grounds of Sublette County, Wyoming, with the right to repair, discontinue and remove the same, in whole or in part, at any time, and with all suitable and necessary right of ingress and egress, under the supervision of the County Engineer.

It is further provided that in the construction and maintenance of said pipe lines and telegraph and telephone and power lines or the removal thereof, the said El Paso Natural Gas Company, its successors and/or assigns,
