OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
March 6, 1956

The Board met in regular session on this date with all members present.

The minutes of the previous meeting was approved as read.

The reports of the various County Officers were approved and ordered filed.

The following Acceptance Agreements were approved and the money ordered paid into the County Treasury:
No. 232, Sublette County Ropeing Club, \$10.00; No. 233, Town of Pinedale, \$50.00; No. 234, State of Wyoming \$104.59.

Having been moved, seconded and carried the following Resolution was adopted:

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Sublette, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Big Piney-Calpet: From a point in Sec. 23, T. 29 N. R. 113 W., Hence southerly to a point in Sec. 20, T. 28 N. R. 113 W. Grading, draining and base course surfacing and mix work. Approximately 6 miles.

NOW, THEREFORE, BE it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract there for, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
