OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
July 3, 1956

The Board met in regular session on this date with Commissioners Donald Sparks and Donald W. Jewett and their Clerk H. H. Summers present.

The minutes of the previous meeting was approved as read.

The reports of the various county officers were approved and ordered filed.

Having been advertised and no protests filed Retail Liquor License No. 54 was granted to Walter H. Floerke.

Acceptance Agreements No. 241, State of Wyoming, \$94.31; No. 242 Martin J. Harris, \$400.00; No. 243 Town of Pinedale, \$50.00; Geo. L. Barp, No. 244, \$30.00 were approved and the money ordered turned into the County Treasury.

The Bond of Max Boroff, Treasurer School Dist. No. 6, \$2000.00 was approved. The Board made a canvass of the Election held June 19, 1956, High School District No. 1 for Trustees with the following results: Three Year Term, Albert Korfanta 60, Bernice Schooley 56, Fred Schriver 61. 1 Year Term, Robert Sievers 83, Horace Swain 1, C. C. Feltner 1.

The Board of County Commissioners acknowledge receipt of the Report of Examination of Sublette County by the State Examiner as of close of business Feb. 29, 1956. After careful consideration of this report they concur with the Examiner in the suggestions he has made and have requested the officials to adjust their methods in compliance therewith.
