OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
January 2, 1957

The board met on this date with all members present.

The bond of Donald Sparks having been approved and having subscribed to the required oath for his office as County Commissioner, on motion regularly moved and seconded and carried he was declared qualified to hold the office of County Commissioner.

Philip Marincic was elected Chairman of the Board for the next two years.

The Bond of Hazel P. Bloom having been approved and having subscribed to the required oath of her office as Clerk of Court, on motion made, seconded and carried she was declared qualified to hold her office of Clerk of District Court.

The appointment of Aune R. Clark as Deputy County Clerk was approved.

Victor McGinnis, James Shipley and E W McNinch were appointed Weed and Pest Commissioners for the Big Piney District for the year 1957.

Forest Reserve Fund was ordered distributed 80% Roads and 20% Schools. Pursuant to Chapter 32, Section 406, 1945 Wyoming Compiled Statutes A School Poll Tax was levied by the Board on every person in Sublette County between the ages of twenty-one years and fifty years inclusive, in the amount of \$2.00.

Assessment Districts were established the same as those established January 3, 1950 and described in the Board minutes of that day in Book 1 of Commissioners Proceedings at Page 476.

On motion regularly moved, seconded and carried the Big Piney Examiner was designated the Official County Newspaper for the next two years.

The Bonds of Aune R. Clark, Deputy County Clerk, \$2000.00; W L Baker, Notary Public, \$500.00 and Rosalie E. Hockett, County Supt. of Schools, \$500.00 were approved.

The appointment of Guy Carr, Gladwon Jensen and Rex Wardell as Special Deputy Sheriff and Deputy County Livestock Inspectors were approved.

Acceptance Agreements No. 261 State of Wyoming, \$156.16 and No. 262, State Game and Fish Commission, \$183.85 were approved and money ordered turned over to the County Treasury.

Having received the proper Petition for the establishing of a County Library the Board appointed Mae Mickelsen, Mrs. James Harrower and Mrs. John Mackey to the Board of Directors of the Sublette County Library, said officers to take office July 1, 1957.
