



Pinedale, Wyoming
January 7, 1958

The Board met on this date with all members present.

The mintues of the previous meeting was approved as read.

The reports of the various County Officials were approved and ordered filed.

Victor McGinnis, James Shipley and E. W. McNinch were appointed Weed and Pest Commissioners for the Big Piney District for the year 1958.

The Forest Reserve Funds was ordered distributed 80% Roads and 20% Schools.

Pursuant to Chapter 32, Section 406, 1945 Wyoming Compiled Statues, a School Poll Tax was levied by the Board on every person in Sublette County between the ages of twenty-one years and fifty years inclusive, in the amount of \$2.00 per person.
