NOW, THEREFORE, BE IT RESOLVED by said Board that the Daniel-Merna Road Project S-1805 (1) be established, the description of said road being as follows:

Commencing at a point in the W $\frac{1}{2}$ NW $\frac{1}{4}$  of Section 26, T. 34 N., R. 111 W. of the 6th P.M., which point is N. 71°44' E. a distance of 562 feet, more or less, from a point which is N. 72°08' E. a distance of 79.4 feet from a point on the West boundry of said Section 26 from which point the Northwest corner of said Section 26 bears North a distance of 1412.4 feet; thence in a Westerly direction a distance of approximately 1.637 miles through Sections 26, 27 and 28, T. 34N. R. 111 W of the 6th P.M., to a point on the North-South centerline of said Section 28 from which the center of said Section 28 bears southerly a distance of 143 feet, more or less. The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk.
