The Bond of Robert W. Sievers, \$2,000.00 as Town Clerk and Treasurer of the Town of Pinedale was approved

Having been regularly moved, seconded and carried the following resolution was adopted:

RESOLUTION.

WHEREAS, The Board of County Commissioners of the County of Sublette is desirous of taking advantage of the provisions of Chapter 99 and/or Chapter 118, Session Laws of Wyoming 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Oiling by road mix method, sanding and miscellaneous work on approximately 3 miles Rye Grass Road.

NOW, THEREFORE, BE IT RESOLVED by said Board:

THAT the Board enter into a written agreement with the COMMISSION covering said improvement in accordance with a contract therefore, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the Chairman of said Board directed to execute said contract on behalf of said board.
