RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming deem the public interest requires that a road be established to be known as the Big Piney-West Road, Project S-1800 (1) described as follows:

Commencing at a point on the ~~west~~ boundary of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 32, T. 30N., R. 112W. from which the northeast corner of the said NW $\frac{1}{4}$ SE $\frac{1}{4}$ bears northerly a distance of 150 feet, more or less: thence running westerly for a distance of approximately five and one-quarter miles through Section 32 and 31 T. 30N., R. 112 W. and Sections 36, 35, 34 and 33T. 30 N., R. 113 W of the 6th P.M. Wyoming; to a point ending on the North boundary of the SE $\frac{1}{4}$ of said Section 33 from which the northeast corner of the said SE $\frac{1}{4}$ bears easterly a distance of 2245 feet, more or less.

WHEREAS, easements have been secured covering all private lands traversed by the above road and are now of record in the office of the County Clerk and Ex-Officio Register of Deeds of said Sublette County, NOW THEREFORE, BE IT RESOLVED, that the Big Piney-West road as described above be and hereby is established as a public road.
