OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

March 27, 1959

Pinedale, Wyoming

The Board met on this date with Board Members Donald Sparks and Donald W. Jewett and Clerk H.H. Summers present.

The Democratic Sublette County Central Committee submitted the names of Joe Murdock, Ward Blackmon, and Frank B. Bray, Sr. one of which the Board was to appoint County Commissioner to take the place of Phil Marincic who resigned.

The Board appointed Frank B. Bray, Sr. as County Commissioner to take the place of Phil Marincic who resigned.

Donald Sparks was appointed to the Welfare Board for a period of two years to take the place of Philip Marincic who reseigned.

The following resolution was passed:

RESOLUTION

Whereas, the Board of County Commissioners of the County of Sublette is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Lawes of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location extent of which is as follows:

Grading, draining and miscellaneous work on 5.876 miles of the Big Piney-Compressor Station Road No. 23. Section of road to be improved was constructed in 1956 as SC-CFM, Project 4282.

NOW, THEREFORE, be it resolved by said Board:

That the Board enter into a written agreement with said commission covering said improvement in accordance with the contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the Said County Clerk of said county; that the Chairman of the Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
