## OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming  
May 5, 1959

The Board met in regular session on this date with all members present.  
The reports of the various County Officers were approved and ordered filed.  
The minutes of the previous meeting was approved as read.  
Buster Martin was recommended as County Water Commissioner.  
Edith Lomax, Big Piney and John M. Anderson, Pinedale, were granted the county scholarships to attend the University of Wyoming.  
Acceptance Agreement No. 327, Town of Pinedale, \$50.00 was approved and money ordered turned into the County Treasury.  
The following resolution was regularly moved, seconded and carried:

## RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the U.S. 187-Cora Road, Project S-1802 (1), described as follows: Commencing at a point on the south boundary of Section 27 T. 34N., R. 110W. of the 6th P. M., Wyoming, from which the southwest corner of said section 27 bears S. 89°35'W. a distance of 1289.2 feet; Thence running Northerly for a distance of approximately 4.1 miles through Sections 27, 22, 21, 16, 15, 10 and 9, T. 34N., R. 110W. of the 6th P. M., Wyoming, to a point of ending on the north boundary of said Section 9, from which the northeast corner thereof bears due east 38.5 feet.

NOW THEREFORE, BE IT RESOLVED, That the said Board do hereby initiate the procedure for the establishment of said road, and declare their intention to establish said road by following out the provisions of Article 3, Chapter 48, Wyoming Compiled Statutes, 1945 as amended, not inconsistent therewith.
