OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyoming
August 4, 1959

The Board met in regular session on this date with all members present.

The minutes of the previous meeting were approved as read.

The reports of the various County Officers were approved and ordered filed.

The Sublette County Republican Central Committee submitted the names of James Jorgensen, Milford "Mike" Steele and Earl Crandall to the Board, one of which was to be selected as County Commissioner to fill the vacancy on the Board caused by the resignation of Donald Sparks. After due consideration the board constituted and appointed Milford "Mike" Steele as a County Commissioner to fill the vacancy caused by the resignation of Donald Sparks. His term of office to run till the next General Election. Donald Sparks resigned as a member of the County Welfare Board. Frank B. Bray, Sr., was appointed as a member of the County Welfare Board.
