

OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyo
Aug. 17, 1959

The Board met in Special Session on this date with members, Donald W. Jewett, and Frank B. Bray, Sr, and Aune R. Clark, Deputy County Clerk Present.

Being regularly moved, seconded and carried the following resolutions were adopted.

RESOLUTION

Whereas the County Commissioners of Lincoln County, on the 4th day of August, 1914, approved the Petition for forming the Town of Marbleton, comprising an area then situated in Lincoln County, and made an order appointing three inspectors to call an election for incorporation, and

Whereas said election was held, and the returns show 32 voters for incorporation and no votes against incorporation, and

Whereas an election of officers was held on the 13th day of October, 1914, but the elected officers failed to act, and there is now no governing board of the Town of Marbleton and,

Whereas the inspectors as above appointed are now unable to act as judges at a new election of officer.

NOW, therefore Mrs. E.E. Clow, Mrs. Dovie Virostko and Lon Gordon, are hereby appointed as inspectors to hold an election, and shall give notice, for two consecutive weeks, of the time and place of holding the first election of officers of the Town of Marbleton, now in Sublette County, Wyoming, by publication in a newspaper, or if none be published within the limits of said town, by posting in five public places within the limits of the same. At such election the qualified electors of said town shall choose officers thereof. Said inspectors shall act as judges and clerks of the election, and otherwise it shall be conducted and the officers elected thereat shall be qualified in the manner prescribed by law for the election and qualification of city and town officers. In the receiving and canvassing votes, the inspectors shall be governed by the laws then existing, so far as the same are applicable, for the election of city and town officers.

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Pole Creek Road, COMMENCING at a point on the northeasterly right-of-way line of State Highway 187 and is S53°08', 3573 feet from the east one-quarter corner of Section 30, T.33N., R.108W. of the 6th P.M. Wyoming, Thence running northerly for a distance of approximately five miles through Sections 30, 19, 20, 17 and 8, T.33N., R.108W. of the 6th P.M. Wyoming;

To a point of ending in NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 8, T.33N., R.108 W. of the 6th P.M., Wyoming which is on the north line of and is 470.2 feet from the north one-quarter corner of Section 8.

NOW, THEREFORE, BE IT RESOLVED, that the said Board of County Commissioners do hereby initiate the procedure for the establishment of said road, and declare their intentions to establish said road by following out the provisions of Article 3, Chapter 48, Wyoming Compiled Statutes, 1945 as amended, not inconsistent therewith.
