



OFFICIAL COUNTY COMMISSIONERS' PROCEEDINGS

Pinedale, Wyo
March 2, 1960

The Board met on this date with Commissioners Donald W. Jewett and Frank B. Bray, Sr. and Clerk, H.H. Summers present.

The minutes of the previous meeting was approved as read.

The reports of the various County Officers were approved and ordered filed.

Acceptance Agreements No. 351, Sublette County Roping Club, \$20.00; Town of Pinedale, No. 352, \$50.00 were approved and money ordered turned into the County Treasury.

Notice is hereby given of a public hearing on the proposed transfer of \$1200.00 from the Cash Reserve Fund to supplement the Sheriff's Fund in the amount of \$1200.00. The said hearing will be held at the office of the BOARD of COUNTY COMMISSIONERS of Sublette County at Pinedale, Wyoming, on the 5th day of April, 1960, at 2:00 o'clock P.M. at which time any and all persons interested may appear and be heard respecting such transfer of funds. Having been moved, seconded and carried the following resolution was adopted:

RESOLUTION

Whereas, the Board of County Commissioners of the County of Sublette is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Oiling by the Road-Mix Method; Crushed Sand-Gravel Seal Coat; and Misc. work on 5.967 miles of the Big-Piney-Calpet Road.

NOW THEREFORE, be it resolved by said Board:

THAT the Board enter in a written agreement with said Commission covering said improvement in accordance with a contract therefore, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the Chairman of said Board and County Clerk of Said county be, and they hereby authorized and directed to execute said contract on behalf of said Board.
