


Having been regularly moved, seconded and carried, the following resolution was adopted:

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Beginning at a point on the Big-Piney Highway (Highway 189) in Section 20, T. 30N. R. 111W., thence Northwesterly for a distance of approximately four miles to a junction with the present North Piney County Road. Grading and Draining, Road to be built to a standard suitable for oiling. (Base and oiling to be placed later under another agreement).



NOW THEREFORE, be it resolved by said Board:

THAT, the Board enter into a written agreement with said commission covering said improvement in accordance with a contract therefore, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; that the Chairman of said Board and County Clerk of said county be, and they hereby authorized and directed to execute said contract on behalf of said Board.
